In consideration of being allowed to participate in the services and activities, including, moto-x riding, cafe access and any other amusement activities provided by iMoto X and its agents, owners, officers, directors, principals, volunteers, participants, clients, customers, invitees, employees, independent contractors, insurers, facility operators, land and/or premises owners, and any and all other persons and entities acting in any capacity on its behalf (collectively "iMoto X"), I agree as follows:

1. I am 16+ years old and wish to participate in the activity
2. I acknowledge that participation in the ACTIVITIES may be physically demanding and that there are risks of injury including serious bodily injury, permanent disability, paralysis and loss of life.
3. I acknowledge that such risks cannot be eliminated entirely without jeopardising the essential qualities of the ACTIVITIES.
4. I expressly agree to accept and assume all the risks existing in the ACTIVITIES.
